

Midwifery (Fees) Notice 2005

Pursuant to Part 6, section 130 (1) of the Health Practitioners Competence Assurance Act 2003, the following notice is given. This notice sets out fees to be charged by the Midwifery Council under the Act from 13 October 2005.

Notice

1. **Title and commencement**—(1) This notice may be cited as the Midwifery (Fees) Notice 2005.
(2) This notice comes into force on 13 October 2005.
2. **Fees**—The Midwifery Council sets the following fees, payable to the council, specified in the attached Schedule.
3. **Tax**—The fees are inclusive of goods and services tax.
4. **No refund**—Fees are not refundable when an application is declined.
5. **Revocation**—This notice revokes Midwifery Fees Notices 1, 2, 3 and 4 of 2004*.

9. Processing and monitoring fee to be paid in conjunction with the first application for a practising certificate by an overseas qualified midwife or a midwife who has registered pursuant to the Trans Tasman Mutual Recognition Act 1997	150.00
10. Processing and monitoring fee to be paid in conjunction with application for a practising certificate where the applicant has conditions on his/her scope of practice	150.00
11. Application to sit the National Midwifery Examination in New Zealand	245.00
12. Application to re-sit the National Midwifery Examination in New Zealand	245.00
13. Application to sit the National Midwifery Examination in any location in New Zealand other than the locations specified by the Midwifery Council in Auckland, Hamilton, Palmerston North, Wellington, Christchurch and Dunedin; plus disbursements at cost	115.00
14. Application for re-consideration of National Midwifery Examination script and result	200.00
15. Application to sit the National Midwifery Examination in an overseas location; plus disbursements at cost	245.00
16. Application for change of midwifery scope of practice	100.00
17. Application for change of conditions on midwifery scope of practice and/or change of conditions on practising certificate	100.00
18. Fee for issue of certificate of standing or supply of documents required by midwife seeking registration in overseas jurisdiction	100.00
